In order to comply with these organic requirements, I will:

- 1) ensure all equipment is free of remnants from previous runs.
- 2) maintain cleaning logs and record, and if needed only use acceptable
  - a. food contact cleaners per Table 7.3 (32.311).
  - b. food contact surface cleaners that do not need to be removed per Table 7.3 (32.311).
  - c. food contact surface cleaners that need to be removed per Table 7.4 (32.311).
- 3) track and label all organic work-in process (WIP), finished goods including individual carcasses identified as 'Organic'.
- 4) keep records, tracking lot numbers of incoming organic product, throughout the custom process and supply copies of these records to the

- 5) ensure prohibited pest control product use is limited to the exterior of the plant including fly control mists, and these will be turned off when organic animals are onsite. Keep records of applications.
- 6) agree to be inspected (announced and unannounced) by the overseeing certification body as deemed necessary. In the case of slaughter/cutting/packing for **both regional & ISO operations** and **processing/packing/labeling for regional operations** agree to be inspected every 12 months during organic services,
